I, _____, agree to the following conditions when purchasing a 2010 VIP Pass.

1. Diamond Hawk GC reserves the right to block off tee times for the exclusive use of the golf course by outside groups contracting with DHGC. VIP Pass holders have no rights to play at these times. The scheduling and timing of these blocked off tee times is subject to change with little or no notice. Diamond Hawk GC will post these dates and times, and update this posting periodically.
2. DHGC reserves the right to revoke the privileges of any VIP Pass holder for any reason. A pro-rated refund will be made.
3. VIP Pass holders will receive the following privileges:
 - 10 day advance tee time privileges
 - No greens fee charges, for themselves, between April 15, 2010 and October 30, 2010.
 - No charges for range balls, to be used only by the VIP PASS holder, between April 15, 2010 and October 20, 2010.
 - Automatic membership in the Diamond Hawk Players Association
 - VIP Pass holder ID Card to be issued. This must be shown every time when registering for play.
4. VIP Pass holders may make a tee time up to 10 days in advance if they will be playing at that tee time. VIP Pass holders may not use their advance tee time privilege to make tee times for use by other players.
5. Cost for the VIP Pass for 2010 is \$ 1900.00 if purchased before December 23, 2009.

6. Cost for the VIP Pass for 2010 is \$ 2150.00 if purchased after December 23, 2009.
7. Unlimited use of an electric golf cart from April 15, 2010 through October 30, 2010 may be purchased by the VIP Pass holder for a fee of \$600.00. The use of the cart is limited to the VIP Pass holder. All other riders who are not VIP Pass holders are responsible for payment of the appropriate cart fee. VIP Pass holders choosing this option are financially responsible for any and all damage to the golf cart they are using at any given time, whether caused by them or another rider.
8. A limited number of lockers are available for rent from April 15, 2010 through October 30, 2010, to the first people who sign up for a VIP Pass. The locker rental fee is \$100.00 per season. Locker renters will be required to keep their locker hygienically clean, and free of dangerous and / or illegal substances. Failure to do so will result in immediate eviction from the locker, with no refund given. Locker renters are financially responsible for any and all damage done to their assigned locker. DHGC will keep a master key to all lockers.
9. VIP Pass holders will be given the right to renew for the 2011 season by paying the posted fee for 2011 on or before December 15th, 2010. After this date, they will forfeit their privilege to renew for the following season, and their slot as a VIP Pass holder will be put up for general sale. This also applies to their privilege to renew a locker rental for the 2010 season, if they had rented a locker in 2009.
