# Corporate Membership Agreement

## Diamond Hawk Golf Course Corporate Membership members acknowledges, understands, and agrees to each of the terms and conditions:

- Bag tags (4 for the foursome package or 2 for the 2-Golfer package) will be supplied and players are to bring bag tags with them when golfing. Bag tags may be used for guests or employees.
- Preferred Tee Times: As a Corporate Membership member you can make tee times up to 10 days in advance (3 days ahead of non-passholders), on a first-come first-served basis. No "standing" tee-times will be honored. Corporate Membership members may not use their advance tee time privilege to schedule tee times for use by other players. Cancellations must be made at least 48 hours in advance or the Corporate Membership member will be charged the full applicable public rate for that tee time. THREE (3) no-shows for scheduled tee times will result in revocation of Corporate Membership privileges in addition to the applicable public rate charges for those no-show tee times. Availability of tee-times is not guaranteed.
- Golf Carts: Double occupancy limited use of an electric golf cart on DHGC property is included with this pass. Corporate Membership members who choose to use a golf cart are financially responsible for any damages to the cart they are using at the time damage is incurred, whether caused by them or their guest(s). Single occupancy carts require additional charge.
- This is not an agreement to reserve a specific tee time. If a specific tee time is desired to be reserved daily, a different agreement and pricing will need to be executed.
- Corporate Memberships are non-refundable and are neither assignable nor transferable.
- Locker Rental: The Locker Rental fee is \$100.00 per locker for the 2021 season. Locker rental will be on a first-come, first-served basis, with a limited number of lockers being available. Locker renters are required to keep the locker hygienically clean and free of dangerous and/ or illegal substances and firearms. Failure to do so will result in immediate eviction from the locker with no refund given. Renters are also responsible for any damage caused to their assigned locker. DHGC will keep a master key to all lockers in case of emergency. DHGC is not responsible for items left in the locker. All personal items must be removed from locker by October 15, 2021.
- Club Storage: \$100.00 each. Club Storage space is limited, and will be on a first come, first served basis. DHGC is not responsible for any lost, broken, or damaged golf clubs, golf bags, or personal items left in golf bags. Club storage is in an open-air area and may accumulate dust.
- NYS Liquor laws prevent private coolers from being brought onto the DHGC and prohibit consumption of beer, wine or liquor not purchased from Diamond Hawk. Individual coolers are attached to each golf cart. Private coolers will not be allowed on the golf carts.

- Passes are valid from date of purchase until October 15, 2021.
